

Corporations Act 2001 - Subsection 340(1) - Order**

Enabling legislation

1. The Australian Securities and Investments Commission (*ASIC*) makes this instrument under subsection 340(1) of the *Corporations Act 2001* (the *Act*).

Title

2. This instrument is ASIC Instrument 11-0979.

Commencement

3. This instrument commences on the day it is signed.

Order

4. ASIC relieves Reclaim Industries Limited (Subject to Deed of Company Arrangement) ACN 090 671 819 (the *Company*) from section 319 of the Act for the financial year ended 30 June 2011 in relation to the reports for that financial year that the Company is required to prepare in accordance with Division 1 of Part 2M.3 of the Act.

Where this order applies

5. This order applies for so long as the Company maintains arrangements for answering, free of charge, reasonable enquiries from their members about the consequences of the Receivership and Deed of Company Arrangement.

Where this order ceases to apply

6. This order ceases to apply when the Company's securities are reinstated to quotation on ASX or 16 November 2011, whichever occurs first.
