### Readmission to official quotation on the Australian Securities Exchange (ASX)

The Board of CWH Resources Ltd (CWH) would like to up-date the market on the progress of the company's readmission to official quotation on the ASX.

The 2012 annual listing fees were paid on 25 August 2011. The company is reviewing and verifying the draft prospectus and diligently working towards its lodgement. The deconsolidation of Chongqing Yuao is progressing well and it is waiting for the final approval from the Chinese Authority.

CWH is on target to become a mining company. With an application for four tenements next to the existing EPM18007 and the announcement of EPM 18085 and EPM 18042, the Company continues to build on its portfolio of tenements in Queensland. Table 1 provides a summary of the tenements in which CWH has an interest. The tenements held are Exploration Permits for Minerals (EPM) and are held 100% by CWH.
