Preparatory Work for Drilling Commences

Aurium Resources Limited (ASX:AGU) and joint venture partner Padbury Mining Limited (ASX:PDY) are pleased to announce preparatory works have commenced at Telecom Hill in readiness for its \$5.5 million drilling program, which will commence later this month.

Track access works are underway to facilitate the extensive RC and diamond drilling programs.

“This is an exciting time for the JV partners as we aim to prove up a Direct Shipping Ore (DSO) source at Telecom Hill,” Aurium Managing Director Terry Quinn said.

“We are now on track to start the largest drilling program in the JV partner’s short Mid-West iron ore exploration history.”

This drilling program aims to further increase and upgrade the already defined JORC compliant inferred resource of 850Mt @ 27.3% Fe with the first priority within the program to be aimed at a DSO exploration target of 10-55Mt at 55-58% Fe’.
