Newland Resources Limited (NRL) has just completed the second of three exploration programs on the Comet Ridge Project (EPC1230). The focus of this drilling has been to define areas of shallow Fair Hill Seam and recover coal cores for coal quality and correlation studies.

A total of 16 holes, with total metreage 1,350 metres, have been drilled with an average depth of 84 metres. Three cores of Fair Hill Seam at depths less than 50 metres have also been recovered. NRL is still waiting on these holes to be geophysically logged to confirm seam thickness.

Figure 1 (located over the page) shows the location of recent non-core and core drill holes and the indicative 50 metre overburden contour. This figure also shows the subcrop of the Fair Hill Seam and the location of initial holes drilled in the western portion of the project area.

The October program planned to commence 5 October 2011, will focus on delineating shallow coal in the west, and recover a number of 100mm cores for drop shatter testing.

Much of this information will be used in the preparation of NRL's maiden Comet Ridge JORC Statement.

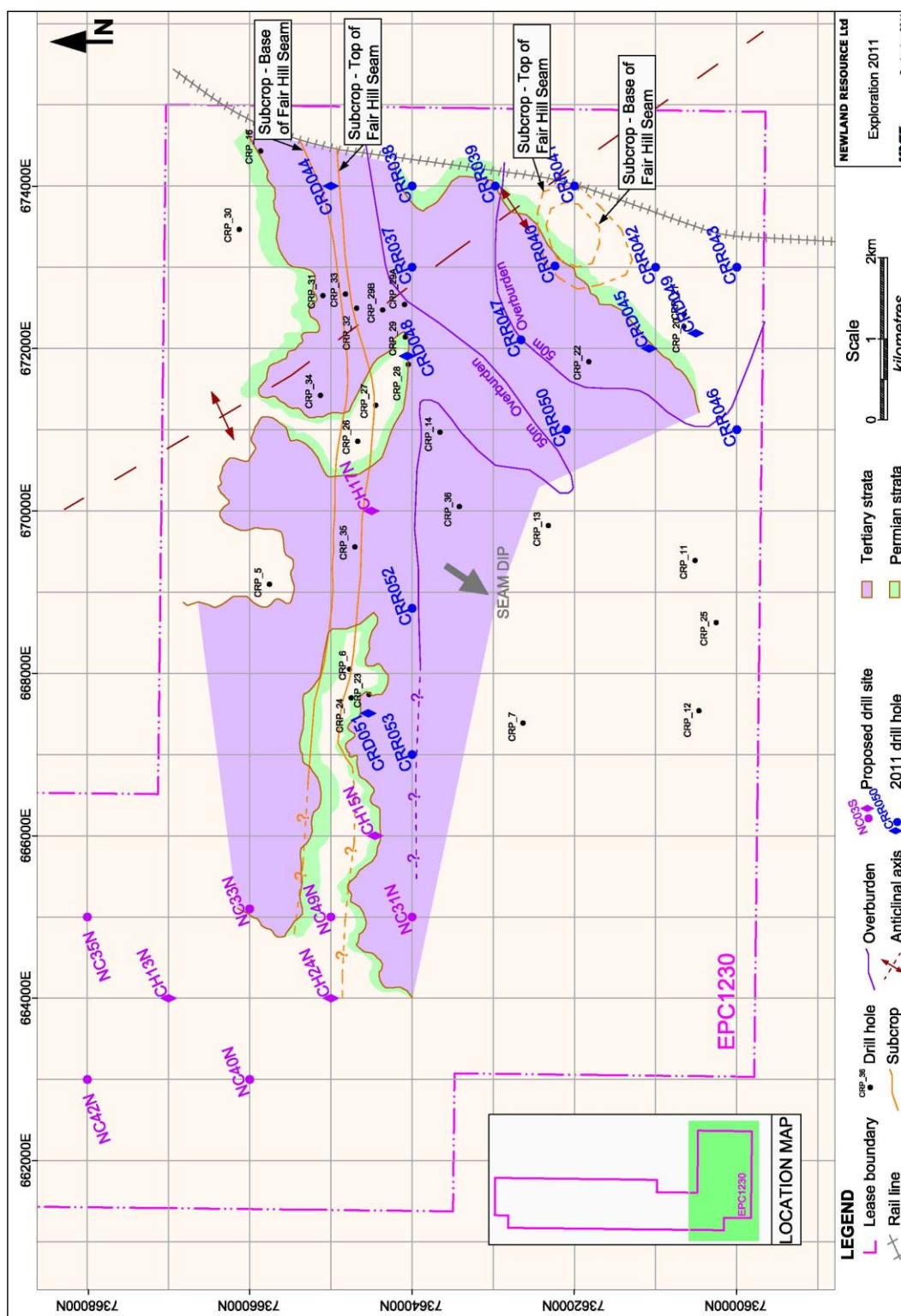


Figure 1 – Comet Ridge Drilling August – September 2011
