Hunnu Coal Limited (HUN.ASX) - Withdrawal and Replacement of Notice as previously Advised in Accordance with Section 671B of the Corporations Act.

Credit Suisse Holdings (Australia) Limited (on behalf of Credit Suisse AG and its Affiliates) (Credit Suisse) advised the market of a holding in Hunnu Coal Limited (HUN.ASX) of 6.53% on 21 October 2011.

Due to an Operational related issue the market was advised by Credit Suisse of the above holding. A purchase of 3.5 million shares was included part of the Notice on 21 October 2011 however, this transaction should have been reflected as a sale and accordingly advised to the Market.

Following the re-calculation of its position Credit Suisse ceased being a substantial holder of HUN.ASX as of 17 October 2011.


