Customers Return of Capital Confirmed – ATO Class Ruling

Customers Limited (Customers) is pleased to advise that the Australian Taxation Office (ATO) has issued its Class Ruling on the proposed capital return to shareholders.

Class ruling

A full copy of the ATO ruling can be found at the ATO's website (Class Ruling CR 2010/2) and on the Company's website, www.customers.com.au/investor_relations. The ruling confirms that no part of the capital reduction will be treated as a dividend for Australian taxation purposes.

Record date

The return of capital of 8 cents per share will be paid to holders of shares on the record date. The Board has determined a record date of 12 February 2010. Consequently, the shares will trade ex the entitlement to the capital return from 8 February 2010.

Payment date and methods

It is anticipated that the share registry will commence dispatching proceeds to shareholders on 26 February 2010.

Those shareholders (as at the record date of 12 February 2010) who have previously completed and returned to the company's share registrar an instruction for direct crediting of payments to a deposit account, will have the capital return in respect of their shares credited to that account.

Shareholders who:

1. would like their capital return payment credited to another account; or
2. have not previously completed and returned to the share registrar an instruction for direct crediting of payments to a deposit account and would like their capital return payment credited directly into a nominated account, must provide their nominated account details to the share registrar (Link Market Services Limited) by the record date at:
