

Response to Price and Volume Query

In response to your correspondence dated 23 April 2010 regarding an increase in the Company's share price and in the volume of trading in the securities, the Company's response is as follows:

1. The Company is not aware of any information concerning it that has not been announced which, if known, could be an explanation for recent trading in the securities of the Company.
2. Not applicable.
3. The Company is not aware of any other explanation for the price change in the securities of the Company other than to refer to the following information which has been contained in releases to the market:
 - a) The Company has approximately \$48 million held in cash and on term deposit in Australia. This equates to approximately \$0.22 per share; and
 - b) Whilst the Company remains alive to a wide range of opportunities that meet the investment guidelines both within China and elsewhere, the current focus is on a broad region encompassing Northern China and Southern Mongolia. The Company is specifically targeting and in some cases, undertaking detailed due diligence on, Coking Coal and Iron Ore projects.
4. The Company confirms that it is in compliance with the listing rules, in particular, Listing Rule 3.1.

PRICE QUERY

We have noted a change in the price of the Company's securities from a closing price of 25 cents yesterday to an intra day high of 29.5 cents today, and a closing price of 21 cents on 16 April 2010.

In light of the price change, please respond to each of the following questions.

Please note that as recent trading in the Company's securities could indicate that information has ceased to be confidential, the Company is unable to rely on the exceptions to listing rule 3.1 contained in listing rule 3.1A when answering this question.

4. Please confirm that the Company is in compliance with the listing rules and, in particular, listing rule 3.1.

Listing rule 3.1

Listing rule 3.1 requires an entity to give ASX immediately any information concerning it that a reasonable person would expect to have a material effect on the price or value of the entity's securities. The exceptions to this requirement are set out in listing rule 3.1A.

In responding to this letter you should consult listing rule 3.1 and Guidance Note 8 – Continuous Disclosure: listing rule 3.1.

If the information requested by this letter is information required to be given to ASX under listing rule 3.1 your obligation is to disclose the information immediately.

Your responsibility under listing rule 3.1 is not confined to, or necessarily satisfied by, answering the questions set out in this letter.

Trading halt

If you are unable to respond by the time requested, or if the answer to question 1 is yes and an announcement cannot be made immediately, you should consider a request for a trading halt in the Company's securities. As set out in listing rule 17.1 and Guidance Note 16 – Trading Halts we may grant a trading halt at your request. We may require the request to be in writing. We are not required to act on your request. You must tell us each of the following.

- The reasons for the trading halt.
- How long you want the trading halt to last.
- The event you expect to happen that will end the trading halt.
- That you are not aware of any reason why the trading halt should not be granted.
- Any other information necessary to inform the market about the trading halt, or that we ask for.

The trading halt cannot extend past the commencement of normal trading on the second day after the day on which it is granted. If a trading halt is requested and granted and you are still unable to reply to this letter before the commencement of trading, suspension from quotation would normally be imposed by us from the commencement of trading if not previously requested by you. The same applies if you have requested a trading halt because you are unable to release information to the market, and are still unable to do so before the commencement of trading.
