### **SHARE PLACEMENT**

The Board of MIKOH Corporation Limited is pleased to advise that it has completed a placement of 19,139,999 shares as a price of \$0.035 per share to raise a total of \$669,900. The placement is to institutional and sophisticated investors introduced by Hanumans Private Wealth and without disclosure pursuant to section 708 of the Corporations Act.

The new shares will be issued in accordance with Listing Rule 7.1, which allows for the issue of up to 15% of a company's capital without the need for shareholder approval.
