### **Confirmation of MIKOH Product Partner for Thailand Electronic Vehicle Registration Project**

13 May 2010

MIKOH Corporation Limited (MIKOH) has formalised the supply of RFID products through its existing manufacturing partner Sirit Corp (Sirit) for the Thailand Electronic Vehicle Registration (EVR) project that was announced on 17 March 2010.

A formal agreement has been signed between MIKOH and Sirit confirming the supply terms and conditions for the full five years plus five-year option of the project. This assures the long-term supply needs for this project through this well-established and mutually beneficial partnership.

Under the supply agreement, Sirit will supply ID5100 RFID readers and Smart&Secure™ tags to MIKOH for implementation in the EVR project. The agreement is expected to generate US\$25M revenue to MIKOH over the next three years.

Sirit was recently acquired by Federal Signal Corporation (NYSE: FSS) of the United States. This further adds to MIKOH's market development opportunities and program management capabilities, and also strengthens MIKOH's Automatic Vehicle Identification (AVI) manufacturing partner's financial strength. ## Sirit Corporation Signs Five Year Agreement to Supply RFID Technology for Thailand Electronic Vehicle Registration Project

**Agreement to generate up to US\$8 - \$10 million over next three years**

IRVINE, Calif., May 12, 2010 /PRNewswire via COMTEX/ --Federal Signal Technologies group company Sirit Corp. ("Sirit"), a global provider of radio frequency identification ("RFID") technology, announces that it has signed an agreement with MIKOH (AVI) Pty Limited, a subsidiary of MIKOH Corporation Ltd, to supply Sirit's RFID technology for the Government of Thailand's Electronic Vehicle Registration (EVR) Systems project. The five-year agreement, with an option to extend the agreement for an additional five years, is expected to generate revenue up to US\$8 - \$10 million over the next three years, including an initial order value of US\$1 million by June 30, 2010.

The Thailand EVR project is expected to utilize hundreds of Sirit's ID5100 AVI Readers along with over 30 million of Sirit's RFID tags over the next five years. Beyond that, it is also estimated the tag requirements for the project will continue in quantities of millions of additional units per year to accommodate new vehicles entering the system. Once affixed to a vehicle, these same tags may be used for other automated applications such as Electronic Tolling, Traffic Flow Management, Emissions Compliance and Vehicle Access and Control.

"We are excited to supply Sirit's best-in-class RFID technology to the Government of Thailand's EVR project," said William Osborne, Federal Signal's President and Chief Executive Officer. "Assuring that tags and readers are authentic is a key element for a truly secure EVR System. This is not just important for vehicle registration, insurance and other compliance matters, but also for a country's national security. The combination of Sirit's high performance ID5100 RFID reader with MIKOH's Safe and Secure™ break on removal tag construction will allow us to provide the EVR project with exactly this required performance."

"Utilizing a global open standard with ISO-18000 6C, Sirit is able to deliver an EVR system solution with reliable high speed performance and reduced operational costs to allow wide scale implementation across large vehicle populations. Now, the Sirit / MIKOH Solution provides a tag that can economically be implemented across a large total population of vehicles, eliminating prohibitive cost barriers previously experienced with battery powered tag technologies," noted John Freund, Sirit President.

"The challenge for MIKOH and its partners was to provide a reliable, secure and economically feasible solution. After researching and testing various options, it became clear that the Sirit products were perfect for the task. With security and reliability being key factors in the decision process for Thailand's National Vehicle Registration System, Sirit was

able to successfully provide the high levels of both physical tag and data security required along with high speed read and write performance," stated Hans Van Pelt, Vice President and General Manager of MIKOH Corporation Ltd.
