Intermoco secures \$2.7 million utilities management contract

- Intermoco signs 5 year agreement to supply embedded network solution for commercial development

Melbourne, 8 April 2010: Utilities management provider, Intermoco Limited (ASX: INT), today announced that the company has entered into a strategic partnership with building and construction group, Buildcorp Commercial ("Buildcorp"), which has commenced with the signing of a \$2.7 million, 5 year contract to supply and manage electricity, voice, and data and communications services to tenants of a new commercial property in Preston, Victoria.

Buildcorp Commercial, as lead building contractor, has been working with property development company, Accord Property Group ("Accord") on the 3500m² commercial project, and the signing of the contract with Intermoco follows the letter of intent signed by Accord announced on the 4th February 2010, and a subsequent approval of the contract terms by Buildcorp. The contract terms require Intermoco to manage the provision of billing, administration, maintenance and support of equipment throughout the duration of the contract.

Buildcorp is a commercial construction group specialising in commercial, industrial and multi-residential construction and is currently working on over 17 construction projects in the greater Melbourne area and has numerous projects currently under consideration.

Newly appointed Intermoco Chairman, Andrew Plympton, said: "We are pleased to have entered into an ongoing strategic partnership with Buildcorp to supply and manage our embedded network services for a portfolio of new and future property projects".

"This is a strong endorsement of our end-to-end utilities solution which has been gaining increasing traction amongst property developers and building and construction groups, and with Buildcorp's expanding portfolio of projects, we expect this to further strengthen the pipeline of opportunities for Intermoco.

"We have had an encouraging start to the relationship with Buildcorp, securing the \$2.7 million contract which will provide a boost to our revenue in the current quarter and into the 2011 financial year. As the company moves towards profitability in fiscal 2010, and with strong margins on these projects of approximately 30%, we are well placed to continue delivering
