Dear Option Holder

YOUR OPTIONS TO ACQUIRE ENEABBA GAS LIMITED SHARES AT \$0.15 PER SHARE EXPIRE ON 30 JUNE 2010

We are writing to you as a registered holder of 30 JUNE 2010 options in ENEABBA GAS LIMITED to remind you that the options will expire at 5:00pm (WST) on 30 JUNE 2010.

Your option holding may be exercised in whole or in part by payment of \$0.15 for each option by no later than 30 JUNE 2010. If payment is not received by 5:00pm (WST) on 30 JUNE 2010 the options will lapse and all rights under the options will cease at that time.

Some of the courses of action available to you as a holder of these soon to expire options are:

- a) Exercise the options on or before 30 JUNE 2010.
- b) Sell your options. Quotation of the options will cease at the close of trading on 23 June 2010.
- c) Do nothing (ie, allow your options to expire). If you do not exercise or sell your options they will expire on 30 JUNE 2010 and your right to subscribe for ordinary shares in ENEABBA GAS LIMITED at \$0.15 per share will lapse.

There is no obligation on option holders to exercise their options. However, under paragraph 6.1 of Appendix 6A of the Australian Securities Exchange (**ASX**) Listing Rules, the Company is required to advise option holders of the information contained in this notice.

The closing price of ordinary shares in ENEABBA GAS LIMITED on ASX was \$0.135 cents on 28 May 2010, being the last trading day in Perth prior to the date of this notice.

During the three (3) months preceding the date of this notice:

- the highest market sale price of ordinary shares on ASX was \$0.245 cents on 1 March 2010; and
- the lowest market sale price of ordinary shares on ASX was \$0.125 cents on 25 May 2010.
