The market value of the portfolio represents prices quoted on overseas stock markets in foreign currencies converted to Australian currency. The rate used for conversion of values of US currency securities was USD 0.89745 (last month USD 0.91535).

The NTA excludes deferred tax assets which include realized and unrealized losses in the portfolio of investments. As at 31 July 2013 there is a total of 1.4 cents per share of tax benefits potentially available to reduce future tax liabilities.
