## MARCH 2013 QUARTERLY ACTIVITIES REPORT

- **Completed 165 kilometres of Stage 1 Seismic on five lines over the Ambatry Lead with exceptional early results.**
- **Interpretation has validated and extended the Ambatry Lead. The Ambatry Lead is now the priority near term drill target.**
- **The Company is preparing to shoot a further 123 kilometres of modern 2D seismic over both the Ambatry and Bezaha leads, starting in the second quarter of 2013.**

### DETAILED INTERPRETATION OF STAGE 1 OF THE SEISMIC PROGRAMME FOR BLOCK 3114 ONSHORE MADAGASCAR<sup>1</sup>

Processing and analysis of stage 1 seismic data has shown the Ambatry prospect to be more faulted than originally anticipated and has confirmed several attractive trapping geometries (a structural anticline and several tilted fault blocks)<sup>2</sup>.

### PREPARATION FOR STAGE 2 OF THE SEISMIC PROGRAMME FOR BLOCK 3114

The Company has been in the process of planning stage 2 of the seismic programme consisting of a further 123 kilometres of modern 2D seismic over both the Ambatry and Bezaha leads.

Stage 2 of the seismic programme will continue during the next quarter and is anticipated to be concluded in June/July 2013, supporting the Company's plan of identifying drill target/s for its first exploration wells.

### CAPITAL RAISING

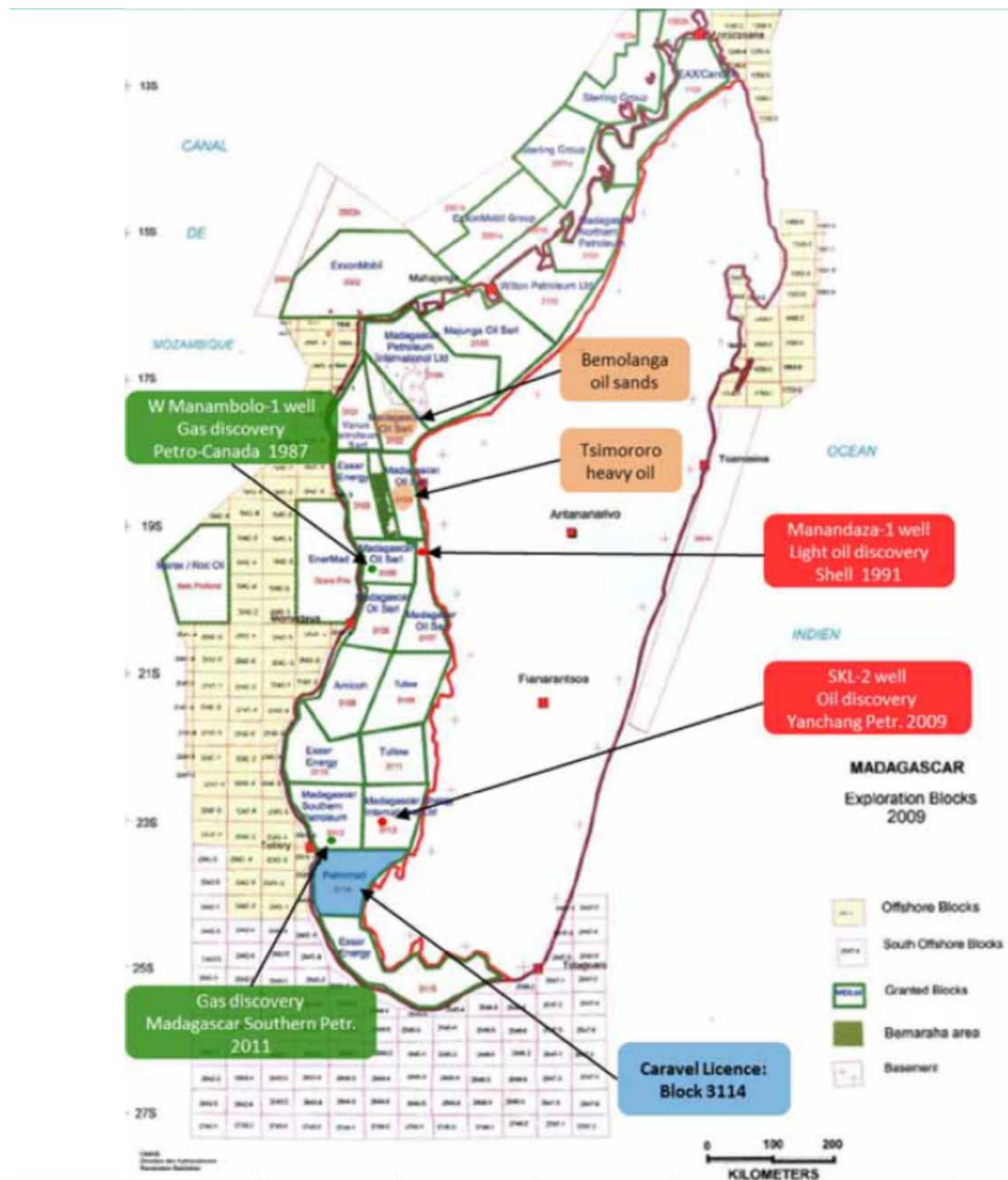

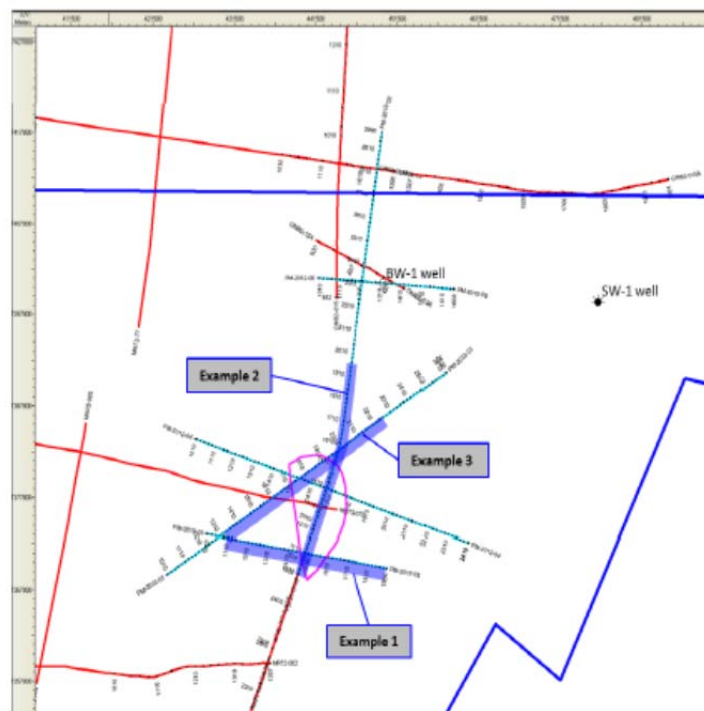

Figure 1: Madagascar Licence Blocks

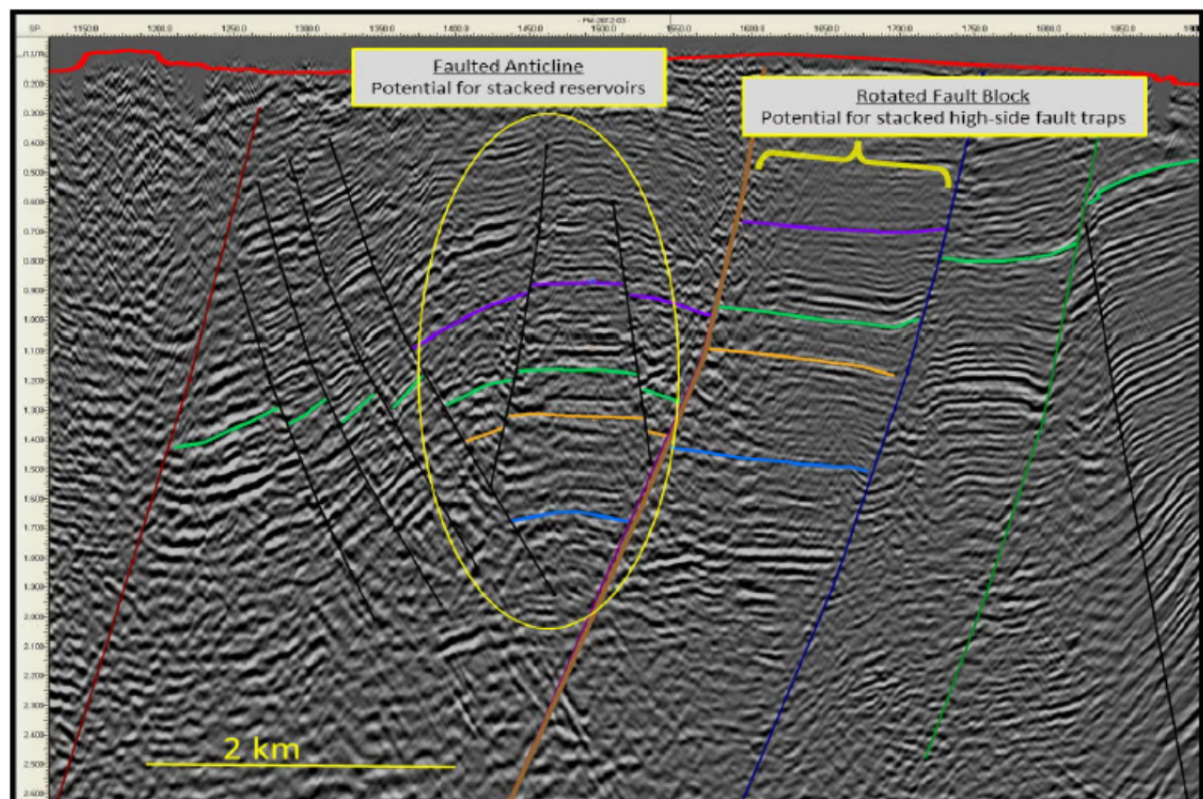


**Figure 2: Results of Stage 1 of Seismic Programme**

- Five 2-D seismic lines totaling 165 km have been acquired and processed.
- Data is of much better quality than legacy data from 1970's and 1980's.
- Preliminary 2013 interpretation reveals a higher degree of faulting than previously interpreted in the area.
- Several fault blocks (including the Ambatry Lead) comprise favorable geometries for the trapping of oil and gas.
- Early mapping validates the Ambatry Lead

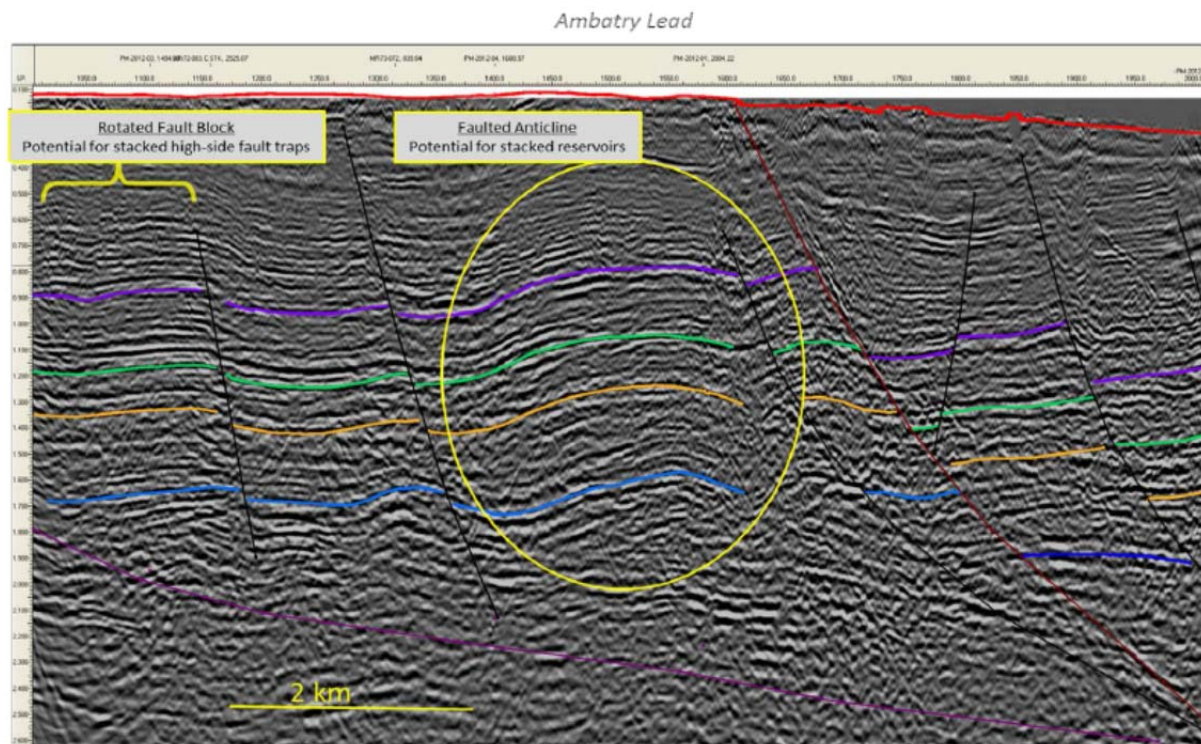
