**Details of transactions and events giving rise to relevant event**

On 21 November 2012, New Dawn Energy made a full cash takeover offer under the Takeovers Code to acquire all of the equity securities in L&M Energy (the Offer).

Between 17 January 2013 – 23 January 2013 (inclusive), a number of L&M Energy shareholders accepted the Offer, resulting in New Dawn Energy acquiring a relevant interest in a further 7,371,753 ordinary shares in L&M Energy for an aggregate price of A\$442,305.18 (reflecting the Offer price of AUD\$0.06 cents per share).

As at the time of filing this notice, New Dawn Energy has received acceptances under the Offer in respect of, in aggregate, 689,250,188 fully paid ordinary shares in L&M Energy.

On 16 January 2013 New Dawn Energy declared the Offer unconditional.

The consideration for the Offer was paid by New Dawn Energy by cheque (sent by mail) or cleared funds (by electronic transfer) on 23 January 2013 to those L&M Energy shareholders and optionholders in respect of whom had valid acceptances had been received by New Dawn Energy by 7.00p.m.(NZT) on 17 January 2013.
