SHARE ISSUE TO WOOLWORTHS LIMITED TAKE UP OF TOP UP RIGHTS

Gage Roads Brewing Co Ltd (Company) (ASX Code: GRB) advises that 1,125,976 ordinary shares have been issued today to Woolworths Limited (**Woolworths**) at an issue price of \$0.15 per share, raising \$168,896.40. This share issue is in relation to Top Up Rights relating to the recent completion of the Share Purchase Plan.

The shares were offered and issued to Woolworths in accordance with the Subscription Agreement and Subscriber's Rights Deed entered into on 15 May 2009 and ratified by shareholders at a general meeting held on 29 June 2009. In summary, the Subscriber's Rights Deed confers to Woolworths the right to acquire shares at market price after a dilutionary event (Top Up Rights) in order to maintain their original 25.25% shareholding in the Company.

The placement to Woolworths has been made without shareholder approval in reliance on the Company's 15% annual placement capacity.

NOTICE UNDER SECTION 708A

The Company gives this notice pursuant to Section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).
