None of these transactions gave rise to change in the percentage level of Temasek's interest in the Shares.  Pursuant to an agreement dated 25 September 2012, Temasek sold 400 million Shares which changed Temasek's interest immediately after completion of the sale on 28 September 2012 to 51.96% comprising a direct interest of 51.88% and a deemed interest of 0.08% due to the holdings of subsidiaries and associated companies.
