Templeton Global Growth Fund Ltd is a long term investor and is not intending to dispose of its total portfolio of investments.		

The market value of the portfolio represents prices quoted on overseas stock markets in foreign currencies converted to Australian currency. The rate used for conversion of values of US currency securities was USD 1.0370 (last month USD 1.0399).

The NTA excludes deferred tax assets which include realized and unrealized losses in the portfolio of investments. In addition to the deferred tax asset shown in the Company's balance sheet at 31 October 2012 there is an additional 7.3 cents per share of tax benefit which has been derecognized from the Company's balance sheet but is potentially available to be offset against future taxation liabilities. As at 31 October 2012 there is a total of 12.5 cents per share of tax benefits potentially available to reduce future tax liabilities.
