## Merger approved by the Court

The Board of WAM Capital Limited (WAM Capital) is pleased to announce the Federal Court has approved the merger with Premium Investors Limited (Premium) via a scheme of arrangement.

The scheme consideration will be calculated as at the calculation date being today 12 December 2012. In accordance with the ASX listing rules, WAM Capital is required to issue an Appendix 3B indicating the maximum number of shares and options that will be issued assuming 100% scrip acceptance and based on the adjusted pre-tax net tangible assets at 30 November 2012. Assuming 100% scrip acceptance, WAM Capital anticipates the maximum number of shares and options that will be issued to PRV shareholders will be approximately 50,850,570 new WAM Capital shares and 50,850,570 new WAM Capital options. The precise number of shares and options to be issued to Premium shareholders will be known and announced after the record date being 20 December 2012.
