## Sale of Subsidiary – UV Guard Australia Pty Ltd

Clean TeQ Holdings Limited (**ASX: CLQ**) has executed an agreement for the sale of UV Guard Australia Pty Ltd, a 100% owned subsidiary. The sale price is \$1.35m plus stock. Contracts for sale were signed on June 28<sup>th</sup> 2012, with completion of sale in late July 2012.

The purchaser of the UV Guard business is Nubian Water Systems Pty Ltd, of Silverwater in Sydney. Nubian is involved in the recycling of water and the provision of clean water for society's use. The UV Guard products complement Nubian's product offerings.

UV Guard was purchased in 2009 as a means for Clean TeQ to enter the water markets in Australia. UV Guard supplies ultraviolet disinfection products and replacement items to the general water and wastewater industries and has been an important contributor to the profile and performance of Clean TeQ over this time. The focus for Clean TeQ is to accelerate the marketing and sales of its proprietary water technologies (CIF™) for use in the large oil, gas and mining segments of the water market, as seen in the recent announcements for entry to the coal seam gas water market in Australia. Given this specific market focus for Clean TeQ over the following years, the sale of UV Guard will enable these financial resources to be targeted towards prospective business.

"UV Guard Australia has been extremely important for Clean TeQ over the past 3 years and has contributed positively to the business. I commend Ross Dive and his team for their great performance over this period and wish them well within the Nubian group. We also look forward to continuing co-operation with UV Guard in the future" commented Peter Voigt, CEO of Clean TeQ.
