### **Commercialisation of DiCOM™ in China**

AnaeCo announces it has signed a Memorandum of Understanding (“MoU”) with Dynagreen Environmental Protection Group Co., Ltd. (“Dynagreen”) a subsidiary of Beijing State-Owned Assets Management Co., LTD (BSAM) with the intention of forming a collaborative relationship for the commercial exploitation of AnaeCo’s DiCOM™ technology in China and overseas.

AnaeCo, BSAM and Dynagreen will work towards creating a framework for potential future commercial operations, initially in China and later overseas. The commercial framework will include terms upon which AnaeCo shall provide technology transfer and licensing rights to exploit the DiCOM™ technology, and terms upon which Dynagreen will roll out the network and capabilities of DiCOM™ across China.

Commenting on the MoU, AnaeCo Managing Director and CEO Patrick Kedemos said, “I am very pleased to have signed this MoU with Dynagreen Environmental Protection Group Co., Ltd. whose capabilities and resources make them an ideal partner for the commercial roll-out of DiCOM in China. The DiCOM technology offers compelling advantages as a waste management solution to many of China’s large and growing urban cities, where the smaller footprint and environmentally benign nature of the DiCOM process will enable the DiCOM plants to be located in the cities’ light industrial areas; in addition the renewable energy generated from the biogas produced by DiCOM, and the organic fertiliser the DiCOM plant produces will make a great contribution to Chinese Municipalities striving to meet the environmental targets laid down by the Central Government.”
