ALLOTMENT OF SHARES TO EXTINGUISH DEBT

Arc Exploration Limited (ARX) confirms that it has today repaid in full all loans provided to it in 2007. The final loan repayment of US\$1.3m was effected by the payment of US\$0.65m in cash and the issue of 80,743,275 fully paid ordinary shares.

The loans were made at a challenging time for ARX and were originally intended to be of a temporary bridging nature to be fully repaid in cash.

The loans were re-negotiated by ARX in 2010, such that they would be repaid in 2 tranches in March 2011 and March 2012 with 50% in cash and 50% by the issue of ARX shares. As one of the loans was provided by the ARX CEO, the allotment of a further 10,765,746 shares in respect of repayment to him requires shareholder approval which will be sought at the forthcoming AGM.

ARX is now debt free with \$4.6m in cash.
