## **SUBSTANTIAL SHAREHOLDER**

Gladiator Resources Limited ("Gladiator" or "the Company") welcomes Veremonte International BV ("Veremonte") on the share register as a substantial stakeholder in the Company. Veremonte has recently lifted its interest in the Company to 19.34% (43,607,675 shares). All the shares were acquired on market over a relatively short period of time.
