**Placement of Shares ("Placement")**

The Company wishes to announce the placement of 55,000,000 fully paid ordinary shares at a price of 0.1 cents per share together with 55,000,000 free attaching options on the basis of one option for each share taken up in the Placement. The options are exercisable at a price of 0.1 cents each on or before 30 June 2014.

The Placement has been made in accordance with a resolution of shareholders at the Annual General Meeting of the Company held on 31 May 2012 and represents the balance of the shares and options approved for the Placement by that resolution.

The shares will rank *pari passu* with the existing issued ordinary shares of the Company. The Placement will raise \$55,000 before costs of the issue.

The principal purpose of the Placement is to assist the Company in funding repayment of short term debt, its ongoing exploration programme and general working capital.
