

I refer to our appointment as Joint and Several Administrators of the above companies on 26 August 2009.

At the first meetings of creditors of the companies held on 7 September 2009, I outlined my intention to make an application to the Supreme Court of Victoria ("the Court") for an extension of the convening period for the companies in order to allow me sufficient time to conduct my investigations into the affairs of the companies and examine any proposals for a Deed of Company Arrangement that may be forthcoming.


On 18 September 2009, Orders were made by the Court extending the convening period for the holding of the second meetings of creditors. Pursuant to the Orders, enclosed is a copy of the Orders which provide that the second meetings of creditors for each of the companies must be convened prior to 17 December 2009 and that you have liberty to apply to the Court in relation to the Orders.

As a result of the Orders made, the second meetings of creditors of the companies must be held by no later than Thursday, 24 December 2009.


