### **IBA Health Group Limited (ASX:IBA) – Notice of change of interests of substantial holder by AEP Financial Services Holdings Pty Limited**

Attached is a notice of change of interests of substantial holder (Form 604) by AEP Financial Services Holdings Pty Limited (**AEPFSH**) and its related bodies corporate including Allco Equity Partners Limited (ASX: AEP).

The Form 604 notes the increase in the voting power of AEPFSH and its related bodies corporate to 27.99%. This has occurred as a result of AEPFSH taking up its full entitlement to new IBA shares pursuant to the institutional component of the 2 for 7 accelerated non-renounceable pro-rata entitlement offer (**Entitlement Offer**) announced by IBA on 12 March 2009, as foreshadowed by AEP in its announcement to the ASX on 12 March 2009.

AEPFSH expects that its voting power will reduce as a result of a further issue of new shares by IBA on 15 April 2009 pursuant to the retail component of the Entitlement Offer. If AEPFSH's voting power reduces by 1% or more, a further Form 604 will be lodged.
