## Unaudited NTA per share July 2023

Kaizen Global Investments Limited ("**KGI**") advises that the unaudited pre-tax Net Tangible Asset (**NTA**) backing per share of the company as at 31 July 2023 is **\$1.1519** and on a post-tax basis is **\$1.1771**.

Recall that a 6.5 cent dividend was paid to all shareholders during the month of May, which reduced the NTA but went to shareholders as cash. So, as a shareholder you simply have the 6.5 cents in your pocket vs on the balance sheet of KGI.

As highlighted in the first half results of 2021, we have taken a tax charge for the sale of the private business in the audited 1H numbers, as per the accounting standards. Investors should be aware that if we make an acquisition of a controlling stake out of the proceeds of the sale, within two years, this tax charge will not crystallise and it will be added back to the NTA.
