AMP Limited (ASX: AMP) (AMP) today announces that it will redeem all of its \$325 million AMP Subordinated Notes 2 (Notes) on their first optional Redemption Date of 18 December 2018.

In accordance with the Note Terms, AMP may elect to redeem some or all of the Notes from 18 December 2018, subject to the Australian Prudential Regulation Authority's (APRA) prior written approval. The redemption has been approved by APRA.

Holders who are on the register on 10 December 2018 will be entitled to receive the face value of A\$100.00 per Note plus the final interest payment of A\$1.1397 per Note (together, Redemption Amount), subject to the Note Terms. The key dates in relation to the redemption are set out below.
