## NZ Top 50 Fund

### Fund update for the quarter ended 31 March 2019

This fund update was first made publicly available on 1 May 2019.

### What is the purpose of this update?

This document tells you how the NZ Top 50 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The NZ Top 50 Fund invests in Australasian equities listed on the NZX Main Board and is designed to track the S&P/NZX 50 Portfolio Index.

Total value of the fund: \$546,371,956

The date the fund started: 7 November 2016

### What are the risks of investing?

#### Risk indicator for the NZ Top 50 Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

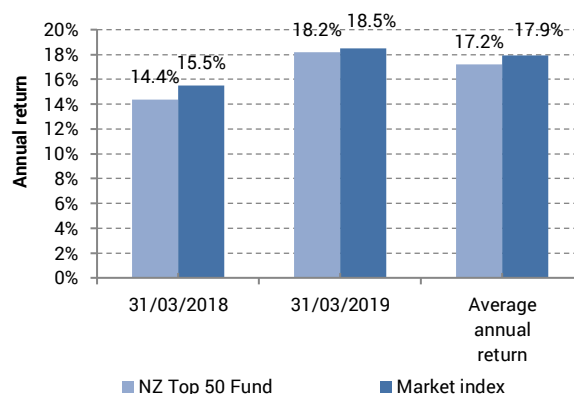
### How has the fund performed?

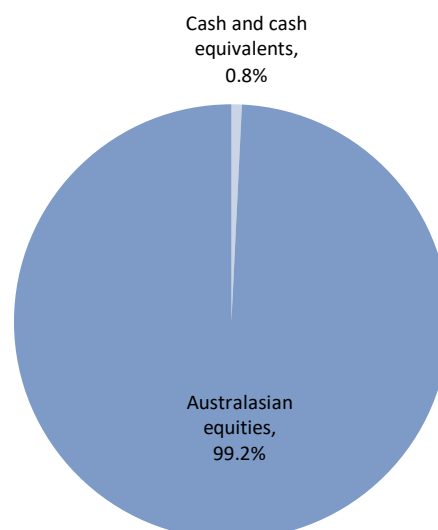
## Example of how this applies to an investor

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$1,817 (that is 18.17% of her initial \$10,000). This gives Tara a total return after tax of \$1,817 for the year.
