On 11 October 2017 O.G Oil & Gas (Singapore) Pte. Ltd. ("OGOG") made a conditional partial takeover offer to purchase shares in NZO (the "Offer"). If the Offer is successful it will result in OGOG holding a majority of the voting rights in NZO (it will hold up to 70% of the ordinary shares in NZO). On 24 October RGH Holdings Limited ("RGH") accepted the Offer in respect of all NZO shares it holds. If the Offer becomes unconditional, and RGH's acceptance is not subject to scaling, all of RGH's shares will be transferred to OGOG. This Offer acceptance is consistent with a joint announcement made by OGOG and NZO on 9 October 2017 and statement contained in NZO's Target Company Statement in response to the Offer.
