In the period from the last disclosure, as part of normal on-market trading activity under discretionary investment mandates, Harbour Asset Management Limited purchased 405,800 ABA shares for total consideration of \$3,805,122 and sold 46,000 ABA shares for a total consideration of \$434,095.
