Transfers between trusts for nil consideration: On 16 November 2015 all of the 189,154 shares previously owned by the PC Barton Trust of which JP Gibbons was a trustee but not a beneficiary were transferred to the beneficiaries. On 9 March 2020 all of the shares in the Estate of NL Gibbons were distributed to the beneficiaries of which 90,237 were transferred to the LC & PL Bennett Trust of which JP Gibbons is a trustee but not a beneficiary and 90,237 were transferred to the DM & JP Gibbons Trust of which JP Gibbons is a trustee and a beneficiary. On 19 October 2020 all of the 664,006 shares in the Estate of RC Gibbons were distributed to the beneficiaries of which 186,335 were transferred to JP Gibbons and 90,000 of those shares were then transferred to Associated Persons of JP Gibbons.

On-market purchases for a total consideration of \$49,548.48: The DM & JP Gibbons Trust acquired 3,994 shares on-market at \$5.04 each on 1 April 2020 and 5,872 shares on-market at \$5.01 each on 2 April 2020.
