

		Kawaroa Trustees Limited is the trustee of a trust associated with Bryce Robert Barnett (Mr Barnett). On 29 June 2020, Centuria New Zealand Holdings Limited (Centuria) make a full takeover offer under the Takeovers Code to acquire all of the equity securities of Augusta Capital (Centuria's Offer). Pursuant to the terms of a lock-up agreement between Kawaroa Trustees Limited and Centuria dated 15 June 2020 (previously attached to a disclosure dated 18 June 2020), Centuria's Offer was accepted on 30 June 2020 in respect of the 5,049,359 ordinary shares in Augusta Capital held by Kawaroa Trustees Limited. Centuria's Offer currently provides consideration of NZ \$0.22 in cash plus an issue of 0.392 of stapled securities in Centuria Capital Group per share in Augusta Capital (subject to certain adjustments further described in Centuria's Offer).
