## More Strong Gold Results at Break of Day

---

- RC drilling continues to intersect high grade gold at Break of Day
- Significant results from the latest assays received include:
  - 5m @ 53.5g/t Au from 138m down hole (16MORC043), including;
    - 1m @ 183.1g/t Au from 138m down hole,
  - 3m @ 54.9g/t Au from 187m down hole (16MORC041), including;
    - 1m @ 142.8g/t Au from 188m down hole,
- The mineralisation is open along strike and down plunge
- Further assays are expected in the coming weeks

Musgrave Minerals Ltd ("Musgrave" or "the Company") (ASX: MGV) is pleased to report further strong assay results from the current reverse circulation ("RC") drilling program at Break of Day on the Cue Project in the Murchison region of Western Australia.




Figure 1: Surface plan of Break of Day drill hole collar locations showing projected surface trace of mineralisation and high grade intersections






Figure 4: Break of Day long section of the Twilight gold lode

Drill hole 16MORC043 intersected **5m @ 53.5g/t Au** (uncut) from 138m down hole including **1m @ 183.1g/t Au** (*Figures 1 and 4*) from 138m down hole in the projected position of the Twilight Lode. This is the highest individual gold assay yet received at Break of Day and extends the Twilight mineralisation a further 30m down dip. The mineralisation is open down plunge. A re-interpretation of the geology (*Figure 2*) suggests a vertical to steep westerly dip to the mineralisation and a possible third parallel gold lode.

Drill hole 16MORC041 located 120m to the north of 16MORC043 intersected **3m @ 54.9g/t Au** (uncut) from 187m down hole including **1m @ 142.8 g/t Au** (*Figures 1 and 3*) from 188m down hole in the projected position of the Velvet Lode. The high grade in drill hole 16MORC041 is at a vertical depth of 162m and the mineralisation is open down plunge (*Figure 3*).

A diamond drilling program is currently being planned that will commence later this quarter.

Musgrave Managing Director Rob Waugh said, *"This is another very good set of results from Break of Day. We have results expected for another 13 drill holes over the coming weeks and look forward to continuing to update the market as more results come to hand."*

### BREAK OF DAY

A total of 32 RC drill holes have been completed for over 7,200 metres as part of the current drill program at the Break of Day Prospect and assay results have now been received for 19 drill holes. Assay results for the remaining 13 drill holes will be received in batches over the next three weeks and will be reported as they become available. The most recent assay results are shown in Table 1.

The mineralisation at Break of Day is interpreted to occur in vertical to steep westerly dipping, twin semi-parallel quartz lodes hosting high grade gold with minor (1-2%) pyrite, within a basaltic stratigraphic sequence. The separation of the Velvet and Twilight gold lodes is varying along strike from 15 to 60 metres. The gold mineralisation is currently open along strike (*Figure 1*) and down plunge (*Figure 3 and 4*).

Sampling was undertaken on one metre intervals in visible quartz lodes and four metre composites outside these zones.

## OTHER TARGETS

A surface EM survey will commence next week on the Cue Project to identify basement conductors that may reflect massive copper-gold sulphide mineralisation. The planned ground survey will cover up to 15 separate targets identified from the airborne versatile time-domain electromagnetic (“VTEM”) survey flown earlier in 2016.

## ABOUT THE CUE PROJECT




Figure 5: Cue Project location plan

The Cue Project (“The Project”) is a Farm-In and Joint Venture Agreement with Silver Lake Resources Limited (“Silver Lake”) (ASX: SLR) where Musgrave can earn up to an 80% interest. The Project consists of the Moyagee Gold and Hollandaire Copper Resources (see ASX announcement 25 November 2015, “Musgrave Secures Advanced Gold and Copper Project”) and surrounding tenure in the highly prospective Murchison province of Western Australia (Figure 5). The Company has met its minimum expenditure commitment for the Cue Project and has commenced the Stage 1 Earn-In to acquire a 60% Joint Venture interest in the Project.

The Company believes there is significant potential to extend existing mineralisation and also discover new mineralisation within the Project area, shown by the recent success at Break of Day.
