

Share Placement – Cleansing Notice

Cleveland Mining Company Limited (ASX: CDG) (Cleveland) issued 8,648,125 fully paid ordinary shares (Shares) on 21 June 2016 at an issue price of A\$0.08 per Share to a convertible noteholder who elected to convert early.
