NOTICE ISSUED UNDER SECTION 708A

Following Shareholder approval obtained on 14 September 2016, Kingsrose Mining Limited (**Company**) has issued 17,268,479 ordinary fully paid shares in the capital of the Company (**Shares**) at 12 cents per share to sophisticated and institutional investors relating to the second tranche of the two tranche share placement announced to ASX on 21 July 2016. A further 5,539,307 Shares at a deemed issue price of 12 cents per share were issued to Michael John Andrews in partial satisfaction of an outstanding loan facility. The Shares are part of a class of securities quoted on the Australian Securities Exchange.
