## **Appendix 4E**

Eureka Group Holdings Limited ("Eureka") is pleased to submit its Appendix 4E for financial year 2016. Some of Eureka's key highlights are summarised below and are more fully detailed in the Annual Report:

- Revenue for FY 2016 was up 97.8% to \$24.1m.
- Earnings before interest, tax, depreciation and amortisation (EBITDA) for FY 2015 was up 201.9% to \$12.5m.
- Net profit after tax for FY 2016 was up greater than 237% to \$10.5m.
- EPS for FY 2016 was up 131.7% to 5.19 cents per share.
- \$4.041m investment property fair value revaluation gain.
- Total assets at 30 June 2016 were up 115% to \$111.3m.
- \$43 million spent on acquiring new low cost accommodation assets in 2016.
- Eureka's new village owner/operator strategy is proving successful and will see Eureka owning 24 villages once settlement is completed for the current contracted village located at Orange, NSW.
- Post completion (of the village acquisition at Orange), Eureka will own 1,254 units comprising 24 villages, whilst managing and/or owning a total of 1,993 units.
- From the acquisitions completed during the year and including the acquisition of the village at Orange, Eureka expects to generate an additional \$5.9m EBITDA on an annual basis.
- Eureka continues to strengthen its balance sheet.
- Eureka experienced strong investor support during FY 2016.
- Market capitalization increased to around \$180 million and Eureka was introduced into the ASX All Ordinaries index.
