The company received the Commonwealth research and development tax rebate in early September 2015 after the lodging of the FY 15 annual tax return. The Company remains eligible for the research and development tax rebate in relation to the current financial year, with the timing of the receipt of the tax rebate expected to be similar to the prior year.

Receipts from the Company's foundry operations are forecast to be higher during the March 2016 quarter due to increased orders for MOCVD work. The company has also lodged an Expression of Interest with the Australian Government for new funding grants to assist with the commercialisation of its RPCVD technology.
