ISSUE OF OPTIONS FOR SERVICES

Dear Madam,

Longreach Limited (ASX:LGO) confirms it has today issued unlisted options, as shown in the attached Appendix 3B, to its adviser, Gleneagle Securities (Aust) Pty Ltd, pursuant to LGO's announcement of the agreed mandate on 24 February 2015. The proposed issue of 180m options previously announced has been superseded by the following issue. The Board is pleased to confirm that there are no further costs outstanding in relation to the 5% purchase of Starlogik.

The details of the options issued are as follows:

- 20 million unlisted options (with an exercise price of \$0.003 and expiry date of 23 February 2018) for services rendered in relation to LGO's acquisition of 5% in Starlogik; and
- 40 million unlisted options (with an exercise price of \$0.003 and expiry date of 23 February 2018) for non-transactional services:
 - rendered to-date including additional advisory services, rent, office services and financial support; and
 - ongoing services to be provided to 30 June 2016.

The Board is also pleased with Starlogik's progress. As previously announced, Starlogik is currently in various stages of discussions with a number of carriers across Africa, SE Asia and Latin America. Their revolutionary ring free technology continues to be well received by these carriers and the Board looks forward to updating the market when a contract is signed.


