NOTICE OF 2015 ANNUAL GENERAL MEETING

The Annual General Meeting of the shareholders of Fiducian Group Limited (**Fiducian**) will be held at Fiducian's premises at Level 4, 1 York Street, Sydney NSW on Thursday, 22 October 2015 at 10.00am.

Ordinary Business

1. DISCUSSION OF FINANCIAL REPORT

To discuss the consolidated financial report and the reports of the directors and auditor for the year to 30 June 2015, and to note the fully franked final dividend in respect of the year ended 30 June 2015 declared by the Board and paid by the Company.

2. ADOPTION OF REMUNERATION REPORT (RESOLUTION 1)

To consider and if thought fit pass the following resolution as a non-binding ordinary resolution:

“That the remuneration report is adopted.”

The remuneration report is set out on pages 7 to 13 of the 2015 Directors Report. The vote on this resolution is advisory only and does not bind the directors or the Company. However, if 25 % or more of votes that are cast are voted against the adoption of the Remuneration Report at two consecutive AGM's, Shareholders will be required to vote at a second AGM on a resolution (“a spill resolution”) for another meeting to be held within 90 days of the second AGM at which all of the Company's Directors, other than the Managing director, must stand for re-election.

3. ELECTION OF DIRECTOR – FRANK KHOURI (RESOLUTION 2)

To consider and if thought fit, pass the following resolution as an ordinary resolution:

“That Mr Frank Khouri, being a director retiring at this meeting, is re-elected as a director of the Company.”

4. OTHER BUSINESS

To deal with any other business that may be brought forward in accordance with Fiducian's Constitution and the *Corporations Act 2001*.

PROXIES AND VOTING

Entitlement to attend and vote

You are entitled to attend and vote at the annual general meeting on Thursday, 22 October 2015 if you are a registered holder of shares at 7pm on Tuesday, 20 October 2015.

Appointing a proxy

If you are entitled to attend and vote at the meeting you may appoint up to 2 proxies to attend and vote on your behalf. A proxy form is included with this notice of meeting. A proxy may be an individual or a corporation, but need not be a shareholder. If you appoint 2 proxies you may specify the proportion or number of votes each proxy is appointed to exercise. If you do not specify a proportion or number, each proxy may exercise half of the votes.

If you appoint a proxy but attend the meeting yourself, the rights of the proxy to speak and vote on your behalf at the meeting will be suspended while you are present.

Signing the proxy form

You, or your attorney, must sign the proxy form.

If your attorney signs the proxy form, Computershare Investor Services Pty Limited must receive the original (or a certified copy) of the power of attorney under which the proxy form was signed. Computershare must receive your completed proxy form (and any supporting documents) by 10.00am on Tuesday 20 October 2013.

How the Chairman will vote undirected proxies

The Chairman will vote undirected proxies in favour of all the resolutions.

Corporate shareholders

A corporation may appoint an individual as a representative to exercise its powers as shareholder, or as a shareholder's proxy. The representative should bring to the meeting evidence of his or her appointment, including any authority under which it is signed, unless it was previously given to Fiducian's share registry (Computershare). The evidence may be either:

- a letter or certificate of appointment of corporate representative, executed in accordance with the company's constitution, authorising him or her to act as the company's representative; or
- a copy of the resolution appointing the person as the company's representative, certified by the secretary or director of the corporate shareholder.

EXPLANATORY MEMORANDUM

These are the explanatory notes provided to assist the shareholders of Fiducian Group Limited in their consideration of the proposed resolutions set out in the notice of the 2015 Annual General Meeting dated 18 September 2015.

Resolution 1 – Remuneration Report

The remuneration report for the financial year is set out on pages 7 to 13 of the 2015 Directors Report. This report sets out the Company's remuneration arrangements for the managing director and non-executive directors.

Recommendation

The directors recommend you vote in favour of this resolution.

For the resolution to be passed it must be approved by 50% of the votes validly cast on the resolution by shareholders eligible to vote. However, under the *Corporations Act*, a vote on the resolution to adopt the remuneration report is advisory only and does not bind the directors or the Company.

Resolution 2 - Retirement and Appointment of Director

Article 8.1 of Fiducian's Constitution provides that an election of directors must take place at each annual general meeting. No director may hold office without re-election beyond the third annual general meeting following the meeting at which the director was last elected or re-elected. If there are no directors who must retire, then a director may elect to retire, otherwise, it is the director who has been longest in office since the last election or appointment. If the directors were appointed or last elected on the same day, the director to retire may be decided amongst the directors or must be decided by lot. The managing director is not included in this process.

The directors have agreed that Mr Frank Khouri is to retire at this meeting and is nominated for re-election.

Details of Candidate

Mr Frank Khouri

Term of office: Director since Fiducian's inception on 20 October 2014 (however, Mr Khouri was also a director of the previous listed company, Fiducian Portfolio Services Limited, since July 2007).

Independent: Yes

Fiducian board committee memberships: *Audit Risk and Compliance Committee, Remuneration Committee*

Other Fiducian directorships: *Fiducian Portfolio Services Limited*

Mr Khouri has been a director of the Company since 20 October 2014 and was also a director of the previous Fiducian listed entity, Fiducian Portfolio Services Limited, since July 2007. He is a Certified Practising Accountant in public practice and has been advising small and medium size businesses for over 37 years. He has been a registered company auditor since 1983. Mr Khouri holds a financial planning franchise and is an authorised representative of Fiducian Financial Services Pty Ltd and has been a practising financial planner for 13 years."

Recommendation

The directors recommend that you vote in favour of this resolution.

For the resolution to be passed it must be approved by 50% of the votes validly cast on the resolution by shareholders eligible to vote.

For your vote to be effective it must be received by 10:00am (AEDT) Tuesday 20 October 2015

How to Vote on Items of Business

All your securities will be voted in accordance with your directions.

Appointment of Proxy

Voting 100% of your holding: Direct your proxy how to vote by marking one of the boxes opposite each item of business. If you do not mark a box your proxy may vote or abstain as they choose (to the extent permitted by law). If you mark more than one box on an item your vote will be invalid on that item.

Voting a portion of your holding: Indicate a portion of your voting rights by inserting the percentage or number of securities you wish to vote in the For, Against or Abstain box or boxes. The sum of the votes cast must not exceed your voting entitlement or 100%.

Appointing a second proxy: You are entitled to appoint up to two proxies to attend the meeting and vote on a poll. If you appoint two proxies you must specify the percentage of votes or number of securities for each proxy, otherwise each proxy may exercise half of the votes. When appointing a second proxy write both names and the percentage of votes or number of securities for each in Step 1 overleaf.

A proxy need not be a securityholder of the Company.

Signing Instructions

Individual: Where the holding is in one name, the securityholder must sign.

Joint Holding: Where the holding is in more than one name, all of the securityholders should sign.

Power of Attorney: If you have not already lodged the Power of Attorney with the registry, please attach a certified photocopy of the Power of Attorney to this form when you return it.

Companies: Where the company has a Sole Director who is also the Sole Company Secretary, this form must be signed by that person. If the company (pursuant to section 204A of the Corporations Act 2001) does not have a Company Secretary, a Sole Director can also sign alone. Otherwise this form must be signed by a Director jointly with either another Director or a Company Secretary. Please sign in the appropriate place to indicate the office held. Delete titles as applicable.
