

## NOTICE UNDER SECTION 708A OF THE CORPORATIONS ACT 2001

South American Iron and Steel Limited (**Company**) advises that on 10<sup>th</sup> April 2015, it undertook a placement of 79,649,000 shares at \$0.0027622 to David Yu International Pty Limited.

A completed Appendix 3B in respect of this placement is attached.

(c) No underwriting arrangements were in place for the placement.


### **Secondary Trading Exemption Notice**


