## WOTIF GROUP SCHEME OF ARRANGEMENT UPDATE AND AMENDED TIMETABLE

Wotif.com Holdings Limited (**Wotif Group**) advises that the Supreme Court of Queensland (**Court**) today heard submissions relevant to certain matters in connection with the Scheme of Arrangement other than clearance from the New Zealand Commerce Commission (**NZCC**). Based on those submissions the Court has indicated that it has no current issues with the Scheme of Arrangement, other than receiving confirmation that the NZCC clearance has been obtained.

The Court hearing has been adjourned to Wednesday, 22 October 2014 at 9.30 am (AEST) with the final Court orders expected to be given at the adjourned Court hearing.
