WESTFIELD GROUP RESTRUCTURE PROPOSAL – COURT APPROVAL**

Westfield Group (ASX:WDC) announces that the Supreme Court of New South Wales today approved the proposed scheme of arrangement between Westfield Holdings Limited and its members. The Proposal to restructure Westfield Group and merge its Australian and New Zealand operations with Westfield Retail Trust has received all necessary approvals and will proceed.

Westfield Group intends to lodge the orders of the Supreme Court approving the scheme of arrangement with ASIC on 24 June 2014. This will be the last day of trading in WDC stapled securities.

Deferred settlement trading of Westfield Corporation (ASX:WFD) and Scentre Group (ASX:SCG) stapled securities is expected to commence on Wednesday 25 June 2014, with normal trading expected to commence on Thursday 3 July 2014. A timetable of the remaining key dates in relation to the Proposal is set out in Annexure A.
