## **ASX ANNOUNCEMENT**

### **Update on Capital Raising**

Central West Gold NL ("CWG") is pleased to advise that it has now received approximately \$933,000 before costs, for the issue of 10,766,475 shares pursuant to CWG's ASX Listing Rule 7.1 capacity and 7,177,650 shares pursuant to CWG's ASX Listing Rule 7.1A capacity. An Appendix 3B is also attached.

The dilutive effect of the Placement on existing shareholders is as follows:

Placement Issue under Listing Rule 7.1	12.0%
Placement Issue under Listing Rule 7.1A	8.0%
Total dilution as a result of the placement	20.0%

Details of the approximate percentages of the issued capital following the completion of the Placement held by pre-Placement shareholders and new shareholders are as follows. This information relates specifically to the portion of shares issued under Listing Rule 7.1A (7,177,650 shares).

Pre-placement shareholders who did not participate in the placement	99.6%
Pre-placement shareholders who did participate in the placement	0.4%
Participants in the placement who were not previously shareholders	0%

The Company issued the shares as a placement under listing rule 7.1A as it believed this was the most efficient mechanism for raising funds at the time given the Company's cash position.

Investorlink Securities Limited was the underwriter for \$500,000 of the amount raised, for an underwriting fee of \$15,000 (3% of the underwritten amount). CWG also paid a placement fee of 6% of the total amount raised.
