### **Byte Power (Hong Kong) Limited signs Memorandum of Understanding with a Business Partner in China**

Byte Power Group Ltd (ASX: BPG) is pleased to announce that its subsidiary Byte Power (Hong Kong) Ltd ("Byte Power Hong Kong") has signed a Memorandum of Understanding ("MOU") to set up a joint venture ("JV") with a local partner Shanghai Huahu Information Technology Co Ltd ("Shanghai Huahu") following the exclusive partnership agreement signed on 19 September 2016 between Byte Power Hong Kong and Wimobilize Singapore Pte Ltd ("Wimobilize").

The purpose of the JV with Shanghai Huahu is to further develop the China market for the purposes of the distribution of Wimobilize Big Data solutions in the territories.

Shanghai Huahu was established in 2004 and is a high-tech software research and development enterprise based in Shanghai. The Company collaborates with technical resource partners, committed to the development of the Big Data and mobile internet technology industries, striving to create and produce a full range of industry data services. Shanghai Huahu has offices in Shanghai, Chongqing and Kunming.

A JV Agreement is expected to be signed by Byte Power Hong Kong with the joint venture partner early next year.
