Please find attached an Appendix 3B for the issue of shares following the vesting of Performance Rights granted to employees under UGL's long term incentive plan.

Section 9.5 (c) of the Target's Statement sets out the treatment of Rights and Performance Rights if CIMIC achieves a shareholding of 50% or more, or a change of control occurs as defined in section 50AA of the Corporations Act. In summary, all the rights and performance rights vest in full.

On 24 November 2016, CIMIC released a substantial shareholding notice advising that it has a shareholding of 50% or more of UGL's issued capital. All the Rights and Performance Rights have accordingly vested as outlined in section 9.5 (c) of the Target's Statement.

The vesting of Performance Rights awarded to employees (not including the CEO) under UGL's long term incentive plan has been satisfied using a combination of issuing new shares and by the transfer of existing shares previously acquired on market from the UGL employee plan trust. The vesting of Performance Rights awarded to the CEO under his long term incentive plan has been solely satisfied by the transfer of existing shares previously acquired on market from the UGL employee trust.

The vesting of Rights awarded under UGL's Deferred Short Term Incentive Plan has been satisfied solely by the transfer of existing shares previously acquired on market from the UGL employee share plan to relevant employees, including the CEO.


