**UBI signs another distribution deal in the USA.
Sentia achieves \$1 million of sales.**

Universal Biosensors, Inc. (ASX:UBI) announces it has agreed a non-exclusive Distribution Agreement with Vinmetrica (USA) for the distribution of its wine testing platform device, Sentia. The Distribution Agreement is for a three-year term; contains standard renewal and termination options available to both parties; and includes an initial commitment to purchase volumes for Sentia devices and strips which will be delivered during October.

UBI also announces that it has achieved \$1 million of sales of Sentia product (launched March 2021).

Mr Craig Coleman, Chairman of UBI said; “We are delighted to achieve the first \$1 million of sales for Sentia. I am very confident of the future success of our Sentia business and more broadly for our developing range of biosensor opportunities.”

Mr John Sharman, CEO of UBI said; “To have reached the \$1 million sales milestone is an excellent achievement, particularly given the difficulties associated with launching a global product in this COVID world. With the signing of Vinmetrica, UBI has 11 distributors around the world with access to more than 25,000 wineries. Our Malic Acid, Glucose and Fructose tests are on track to be launched before the end of 2021 and we are well positioned to deliver sales growth during 2022.”

The Sentia analyzer complements the existing Vinmetrica portfolio of instruments and our online platform has proven successful in reaching a wide array of customers.”
