### Quarterly Activities and Cash Flow

Consolidated Financial Holdings Limited (CWL or the Group) is pleased to announce its December 2021 Quarterly Activities Report:

- The cash balance for the Group at the end of the quarter was approximately \$570k.
- In accordance with Listing Rule 4.7C.3, the Company advises that the payments to related parties and their associates reported at Section 6 of the December 2021 Appendix 4C relates to non-executive directors' remuneration.
- At item 2.5 *Other Proceeds*, the Group was the underbidder in relation to a candidate business as previously disclosed. The \$78k of receipts relate to due diligence expenses that were recouped under a cost agreement with the vendor for significant works undertaken.

### Other Business

Further to previous announcements, we continue to seek a compelling new operating business.

We expect that the securities of CWL will remain suspended until the Group develops or acquires a new operating business.
