June 2020 Quarterly Shareholder Update and Appendix 4C

Key highlights:

- Shareholder approved the issue of Tranche 2 Placement shares to Finnavate. The issue of Tranche 2 Placement shares was completed on 2 July 2020, raising a total of \$106k.
- Shareholders have also approve the issue of 2,702,703 options exercisable at \$0.0001 expiring 1 January 2022, in lieu of 6 months (January 2020 to July 2020) cash payment of salary (\$100,000) to Mr Kotti pursuant to his remuneration arrangements announced on 6 January 2020.
- There were no substantive business activities during the quarter. The Company remain focused on building commercial proof-points for its existing technology with partners and customers. Concurrently, the Company is also reviewing possible mergers and acquisitions with IT companies which will be complementary to Gooroo's existing technology, experience and customer base.

Related Party Payments:

During the quarter, the Company made payments of \$27.6k to related parties and their associates, of which \$18.6k was for director fees and \$9k was for consulting services.

Mr Richard Symon has agreed to reduce his director fees from 1 July 2020 from \$3,333 per month to \$2,000 per month, with the balance subject to shareholder approval to convert into ordinary shares at the next available general meeting. Mr Tom Brown has agreed to reduce his director fees from 1 July 2020 from \$6,000 per month to \$3,000 per month, with the balance subject to shareholder approval to convert into ordinary shares at the next available general meeting.
