

## **CANNINDAH RAISES \$1.25 MILLION TO ADVANCE EXPLORATION AT PICCADILLY AND CANNINDAH**

Cannindah Resources Limited is very pleased to announce that as a result of the increased investor interest in the Company following its recent announcement of the review of the Mt Cannindah project, the Company has raised \$1,250,000 before transaction costs through the issue of 20,833,334 shares in a placement that received cornerstone support from Fresh Equities Limited.
