## ASX ANNOUNCEMENT

### COURT APPROVES SCHEME OF ARRANGEMENT

Australian Leaders Fund Limited (ACN 106 845 970) (**ALF**) confirms that today the Federal Court of Australia made orders approving the scheme of arrangement between ALF and its shareholders (**Scheme**) on the terms set out in the Scheme Booklet dated 2 February 2021.

It is expected that a copy of the Court's orders will be lodged with the Australian Securities and Investments Commission on 17 March 2021, at which time the Scheme will become legally effective.

If this occurs, ALF shares will be suspended effective from close of trading on ASX on 17 March 2021 and on 26 March 2021 ALF shareholders will receive the 3.1 cent dividend and 1 new unit in the Watermark Fund for each ALF share held as at 7pm (Sydney time) 22 March 2021.
